

**RED LOBSTER GOLDEN CARD PROMOTION**  
**OFFICIAL RULES**

**NO PURCHASE NECESSARY TO ENTER, WIN, OR CLAIM A PRIZE. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

**OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE 50 UNITED STATES, THE DISTRICT OF COLUMBIA, AND CANADA (EXCLUDING QUEBEC) WHO ARE AT LEAST 18 YEARS OLD OR THE AGE OF MAJORITY IN THEIR PLACE, PROVINCE OR TERRITORY OF RESIDENCE AT THE TIME OF ENTRY.**

The Red Lobster Golden Card Promotion ("Promotion") is sponsored by Red Lobster Management LLC ("Sponsor"), 450 S. Orange Ave., Suite 800, Orlando, FL 32801, and is administered by Prize Logic, LLC, ("Administrator") 25200 Telegraph Road, Suite 405, Southfield, MI 48033, USA ("Administrator").

- 1. PROMOTION TIMING:** The Promotion begins on January 18, 2018 at 12:00 AM Eastern Time ("ET") and ends on February 8, 2018 at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotions' official clock.
- 2. ELIGIBILITY:** The Promotion is offered only to legal residents of the fifty (50) United States, the District of Columbia, and Canada (excluding Quebec) who are at least eighteen (18) years of age or the age of majority in their place, province or territory of residence at the time of entry. Employees, officers, directors, representatives, and agents of Sponsor, Administrator, MWW Group, LLC, and each of their respective parent companies, subsidiaries, affiliates, advertising and promotion agencies (collectively, "Promotion Entities") and each of their immediate family members (*e.g.*, spouse, parent, child, sibling, and their respective spouses and the "steps" of each, regardless of where they reside) and persons living in the same household of each, whether or not related, are not eligible to enter or win. All applicable federal, state, provincial, territorial, and local laws and regulations apply. Void in Quebec and where prohibited or restricted by law. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor and Administrator's decisions, which are final and binding in all matters related to the Promotion. one (1) entry (“Entry”) into the Promotion. Retweets are not eligible to earn an Entry into the Promotion.

**B. Enter Via Instagram:**

- i. Sign into his/her Instagram account (entrant may create an Instagram account for free if he/she does not already have one);
- ii. Become a follower of @Redlobster on Instagram (if not already following @Redlobster). There is no charge to sign up for Instagram or to follow @Redlobster; and
- iii. Compose a new Instagram post with a photo showing his/her most memorable Red Lobster experience/memory including the hashtag “#RLGoldenSweepstakes” to receive one (1) Entry into the Sweepstake. Regrams are not eligible to earn an Entry into this Promotion.

**C. Enter Via Facebook:** An entrant may participate on Facebook by visiting the Sponsor’s Facebook Page <https://www.facebook.com/redlobster> (“Page”). During the Promotion Period, Sponsor will make a Facebook post on the Page inviting participants to enter this Promotion (“Invitation Post”). To enter the Promotion on Facebook, an entrant must post a photograph showing his/her most memorable Red Lobster experience/memory with the hashtag “#RLGoldenSweepstakes” as a comment to the Invitation Post during the Promotion Period.

By entering the Promotion and using the hashtag #RLGoldenSweepstakes, entrant hereby agrees to be bound by these Official Rules. An Entrant must have a non-private Twitter account or Instagram account to enter the Promotion using Twitter or Instagram and must be a follower of @Redlobster on the platform used for sixty (60) days after the end of the Promotion Period for winner notification purposes to be eligible to win/claim a prize. Due to the way Instagram operate its services, entries from users with protected or private accounts (i.e., entrant has set his/her account so that only people the entrant has approved can view his or her updates) may not be received. This Promotion is in no way sponsored, endorsed, or administered by, or associated with, Instagram, Twitter, or Facebook. Each entrant specifically agrees to release Instagram/Twitter/Facebook from any and all liability associated with this Promotion. Entries will be deemed made by the authorized account holder of the account the Entry is submitted from at the time of entry. The “authorized account holder” is the person who is assigned to the Instagram/Twitter/Facebook account by the online service provider.

Once an Entry is submitted in the Promotion it may be made available on Sponsor’s social media accounts or other websites for viewing by the general public and any such posting will be deemed made at the direction of the entrant within the meaning of the Digital Millennium Copyright Act and the Communications Decency Act.

Canadian residents will be required to correctly answer a timed mathematical skill-testing question as further described in Section 6 before being declared a potential winner.

Your purchase, use or acceptance of this Gift Card constitutes acceptance of the following terms and conditions. This Gift Card is issued by and represents an obligation solely of RLSV, Inc. Each time you use this Gift Card, we'll deduct the purchase amount from the balance until you've used the full balance of the card. You can add to the card balance at any time. This Gift Card cannot be redeemed for cash (except as required by law) or applied as payment to any account. The value of this Gift Card will not be replaced if the card is lost, stolen, altered, destroyed or damaged. This Gift Card does not expire and may be used at any participating Red Lobster restaurant located in Canada. Approval required to advertise this Gift Card. In no event will more than the stated number of Prizes be awarded during the Promotion Period.

If, for any reason, more Prize notifications are sent (or more claims are received) than the Prizes offered, as set forth in these Official Rules, Sponsor reserves the right to award the stated number of Prizes through a random drawing from among all eligible Prize claims received. No Prize substitution or exchange will be allowed, except by Sponsor, who reserves the right to substitute a Prize, or component thereof, of equal or greater value in case of unavailability of a Prize or a Prize component.

FOR ANY DISPUTE SHALL BE IN THE ORANGE COUNTY, FLORIDA. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY THE AMERICAN ARBITRATION ASSOCIATION IN ACCORDANCE WITH ITS ARBITRATION RULES AND PROCEDURES OR SUBSEQUENT VERSIONS THEREOF ("AAA RULES"). THE AAA RULES FOR SELECTION OF AN ARBITRATOR SHALL BE FOLLOWED, EXCEPT THAT THE ARBITRATOR SHALL BE EXPERIENCED AND LICENSED TO PRACTICE LAW IN FLORIDA. ALL PROCEEDINGS BROUGHT PURSUANT TO THIS PARAGRAPH WILL BE CONDUCTED IN ORANGE COUNTY, FLORIDA. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL OR INCIDENTAL DAMAGES OR HAVE DAMAGES MULTIPLIED OR OTHERWISE INCREASED, INCLUDING ATTORNEYS' FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF. ENTRANTS AGREE THAT THE RIGHTS AND OBLIGATIONS OF ANY ENTRANT AND/OR PROMOTION ENTITIES AND/OR ANY OTHER PARTY SHALL BE RESOLVED INDIVIDUALLY, WITHOUT RESORT TO ANY FORM OF CLASS ACTION.
